MEMBER STATES AND THIRD COUNTRIES QUESTIONNAIRE

- -Contact
- -State of legislation and use of cloning For TCs – plans to draft special legislation
- -Imports of clones and reproductive materials from cloned animals by private companies or breeding centres
- -Special identification and registration of : cloned animals, reproductive material from cloned animals, imports of clones
- -Current knowledge about the impact of cloning on the health and welfare of animals
- -Risk assessment on the safety of food derived from clones



MEMBER STATES AND THIRD COUNTRIES QUESTIONNAIRE

The questionnaire for TC is also meant to compare the current state of cloning in TC with the current legislation options for the EU:

Existence, or plans to set up, a traceability system:

- for food derived from cloned animals
- for food derived from offspring

And finally it requests general information on cloning for research purposes, even unrelated to food production.



The questionnaire is structured in four main sections:

General information on the respondent

Background information on the subject

Preferences about the possible legislative measures

Preferences regarding EU policy options



Sections:

- 1- Identification of the type of respondent, based on its role (individual, academic, entreprise, professional organization, international organization, etc.), country of origin and perceived level of knowledge about the subject
 - Specific section to identify SMEs
- 2- Clarifying information on the terms used in the questionnaire (glossary), on existing scientific information and current legislation. Although the IPM is not meant to inform the public about cloning, some **background information** is essential to properly answer it.



- 3- An explanation of the **possible measures** on animal cloning for food production prepares the respondent for the core of the questionnaire. Respondents state their preferences about four main measures:
 - Ban and pre-market approval
 - Identification and registration
 - Traceability
 - Consumer information (labelling)



4- The **policy options** that have been set up in the roadmap are explained and the respondent is asked to state its preferred choice. This question is meant to summarize the public's opinion about concrete policy solutions.

A final open question allows the respondent to provide comments or raise issues that were left uncovered by the questionnaire.

Additional questions specific to SMEs will gather the information needed for the SME test.

- 5. Total ban
