### Instructions on how to provide the required information

Title of the example	choose a title that would also attract the attention of people from outside the agricultural community; the title should refer to the main aim and/or the outcomes of the example being presented		
Country/ region	provide the name of the country as well as the region/specific location where the example comes from, include the location name/protected area; a map of the location may be added		
Year / duration	indicate the date on which farming practice/management at farm level or in agri-cooperatives has been changed; should it be a project, indicate the starting year and the final year or whether open-ended		
Goal	indicate how the example contributes to the concept of circular economy and/ or which resource efficiency gains are foreseen or have been achieved		
Initiator/ participants	highlight the involvement of farmers' organisations /farmers/agri- cooperatives		
Approach used	the organisation of/the steps for implementing the action : for individual initiatives/collective initiatives - explain how the farmers/agri-cooperatives' are involved/trained/organised		
Outcomes for the environment	benefits : e.g. reduction of energy consumption, waste, inputs, and reduced use of natural resources in agriculture and forestry		
Economic, social outcomes	financial impacts of changed practices/investments/innovative approaches; (potential future) cost-savings, jobs		
Conclusion	summarise the key message of this example; the lessons learnt; framework/ option for similar action elsewhere		
Material to be displayed at the stand	Indicate whether you intend to provide material such as posters, illustrations, photos, brochures, DVDs, CD-roms, internet pages, models, sample,		
Communicatio n / web link	indicate whether the outcomes were/are communicated (website, conferences, brochure); if applicable indicate a website where additional information can be found or where the best practice example is presented
