The Commission's services have informed us that an **Advisory Group meeting on International Aspects of Agriculture**, will be held on **Monday, 25 June 2012 from 9:15 a.m. to 5:30 p.m.** at Centre de conferences Albert Borschette, rue Froissart 36, 1040 Brussels.

For the meeting on 25<sup>th</sup> June 2012, the Commission has allocated **27 expert seats** to the Copa-Cogeca delegation. In order to draw up a list of representatives, we will use the following method:

I would like to ask you to decide per **national delegation** (i.e. not per member organisation), who will be nominated to represent your national delegation in this Advisory Group. The seats will be distributed in accordance with the population in each Member State, starting with the Member State with the highest number of inhabitants disposing over the first seat etc.

Considering the foregoing I would like to ask you to **nominate two representatives per national delegation in order of preference** enabling the Secretariat to draw up the list of the Copa-Cogeca delegation. I trust that you will be able to reach an agreement within your national delegation on deciding who will be nominated. Please bear in mind that preference should be given to those experts with knowledge/expertise in the field of international trade and development.
