




Change in Poultry Slaughter - Oct 2015/ Oct 2016

Placings of broiler chicks (1 000 pieces)






Forecast and Production of broiler (In tonnes)










EU Poultry meat Imports

EU IMPORTS of Poultry Meat (1000 EUR)








EU Poultry meat Export

EU EXPORTS of Poultry Meat (1000 EUR)





3 import regimes

1. TRQs for Ukraine

- **COMMISSION IMPLEMENTING REGULATION (EU) 2015/2078** of 18 November 2015 opening and providing for the administration of Union import tariff quotas for poultrymeat originating in Ukraine
 - 16 000 tonnes: poultry meat selection of cuts and carcasses
 - 20 000 tonnes: chicken frozen carcasses


2. Erga omnes TRQs

- **COMMISSION REGULATION (EC) No 533/2007** of 14 May 2007 opening and providing for the administration of tariff quotas in the poultrymeat sector
- **COMMISSION REGULATION (EC) No 616/2007** of 4 June 2007 opening and providing for the administration of Community tariff quotas in the sector of poultrymeat originating in Brazil, Thailand and other third countries
- **COMMISSION REGULATION (EC) No 1385/2007** of 26 November 2007 laying down detailed rules for the application of Council Regulation (EC) No 774/94 as regards opening and providing for the administration of certain Community tariff quotas for poultrymeat



(in tonnes CWE)




EU Imports of Poultry meat from UKRAINE in 2016 (Jan to Dec)
(in tonnes CWE)




EU Poultry meat imports from Ukraine (in EURO)



HPAI H5N8 in wild birds, captive birds
and in poultry 2016-2017

- Since 4 November 2016, when Hungary reported the first outbreak of HPAI H5N8 in poultry, the **outbreaks in poultry holdings have spread to 16 EU Member States**.
- As of 9 February 2016, the **most affected Member States** in terms of number of outbreaks are **Hungary (231), France (226), Bulgaria (63) and Poland (44)**. Other affected Member States Germany (52), Austria (2), Denmark (1), Sweden (3), Netherlands (9), the United Kingdom (8), Slovakia (6), Romania (8), Croatia (2), Czech Republic (25), Greece (3) and Italy (4). *Number of outbreaks in respective Member States is under development.*
- Mostly affected are holdings with ducks and geese but also turkey, chicken breeding and laying hens holdings. Wild birds are at the origin of the virus.
- Affected Member States immediately took **EU control measures (Council Directive 2005/94/EC) to prevent virus spread to other holdings and established protection and surveillance zones** around the infected holdings.
- The disease situation and the measures adopted by the Commission are regularly reviewed during the periodical meetings of EU Member State experts at the **Standing Committee on Plants, Animals, Food and Feed**.

- Number third-country trading partners raised **temporary restrictions on imports of hatching eggs, day old chicks, poultry and poultry products from Member States affected by those outbreaks.**
- Trade partners generally follow EU regionalisation, some imposed **country-wide bans for some of the biggest EU poultry exporters** (DG TRADE 25/1/2017):
 - **NL** (by Bangladesh, China, Ethiopia, India, Israel, Korea, Malaysia, Nepal, South Africa, Sudan, Thailand), **UK** (by China, Singapore), **PL** (by China, Israel), **AT** (by Ukraine), **DE** (by Israel, Japan, Korea, Singapore, South Africa), **DK** (by Japan, Korea, Singapore, South Africa, Ukraine), **FR** (by South Africa), **HU** (by Israel, Japan, Korea, South Africa), **IT** (by Nigeria), **SE** (Korea, Turkey).
