




Thai Union is Thailand's main canned tuna producer, Chicken of the Sea brand was bought some years ago

- free trade agreements very important








- Maruha Group main canned fish producer in Japan




Galicia – loss in employment

- outsourcing of labour intensive production processes (Latin America)

- started in 1903
- tuna canning in San Diego started in 1911
- boom in the 1950s and 1960s
- last tuna cannery in San Diego closed in 1984
- in 2009 return to US mainland for tuna canning!!

US canning




- StarKist closed cannery in Puerto Rico in 2001
- Star-Kist tuna cannery in American Samoa closed in 2009









Production of canned fish in Poland and Baltic States




Production of canned fish in Poland



Production of canned fish in Poland

- important sector of industry
- employment growing
- modernization and concentration ongoing
- relative cheap work force, but skilled technological staff
- further concentrations likely

Production of canned fish in Baltic States



Production of canned fish in Baltic States

- Latvia we will hear more later on
- Lithuania experienced problems with its canning industry
- Estonia also reported lower production in recent years

Findings

- Canning in developed declining, due to higher labour costs
- Concentration in traditional canning countries
- Further expansion of canning depends on raw material supply and on prices

Findings (cont.)

- Canned fish prices stayed very low in the last two decades
- Poland is doing pretty well, as main canned herring supplier to Germany
- Lithuania and Estonia experienced some problems in recent years
- Labour costs in Baltic countries and Poland will be key to any further development

Findings (cont.)

- introduction of new technologies and innovative production methods key for Baltic states and Poland
- Improve the quality and the range of products
- Maintain the level of employment in this sector which is exposed to strong competition and needs a substantial restructuring
